- ◆ Up to and including 9 years
- ◆ 10 to and including 13 years
- ◆ 14 years to and including 17 years (intermediate division)

### **THE POOMSE CONTESTANTS HAVE FREE CHOICE IN WHAT POOMSE(S) THEY PERFORM**

#### **RULES FOR INDIVIDUAL POOMSE**

- ◆ Yellow, Blue, Red & Black belt divisions will only perform one (1) poomse of own choice.

#### **Judging**

- ◆ Judging shall be by two judges, who shall display the score, which shall be added, with the total being the given score.

#### **Competition procedure**

- ◆ The contestant's name shall be called
- ◆ The contestant shall walk to the square marked in the poomse court
- ◆ The competitor shall be given the command **CHARYOT KYONGRYE** at which time they shall bow to the central table.
- ◆ The contestant shall be asked by the ring coordinator to **PRESENT** at which time the contestant shall name the poomse they wish to perform.
- ◆ The ring coordinator shall then give the command **JUMBI** followed by **SIJAK** at which time the competitor shall commence their chosen poomse.
- ◆ At the completion of the poomse the contestant shall remain stationary in the last movement until given the command of **KUEMAN** at which time they will move back to the **JUMBI** position
- ◆ The contestant shall stay in **JUMBI** position until the ring coordinator gives the command **CHARYOT KYONGRYE** at which time the contestant shall bow to the central table and then return to the contestant waiting area.
